- Shelter Plans: Robert Seitzinger from CT Consultants explained they are waiting for confirmation that the KY Procurement Coalition can be used to purchase the new shelter materials; this would streamline the use of the grant funds. Mr. Seitzinger should know more soon and will determine the route for getting bids on the project. He will also attend the March 1 meeting to give an update and move the project forward. The project is still planned to be completed this spring and summer.
- Budget for next year: The Board discussed estimates for costs associated with converting the old basketball courts into 2 or 3 pickleball courts. CT will provide some survey info to help determine if the drainage in that area is adequate. Discussion will continue in March to determine if the Board will include this project in the 2023/24 budget.
