APPROVAL OF MINUTES: April 6, 2023, Regular Meeting

MOTION: Susan Vanlandingham made a motion to approve the minutes of the April 6, 2023. Regular Meeting, seconded by Tom Baldridge. The motion passed 5-0-1, Stacey Graus abstained.

UNSCHEDULED VISITORS AND GUESTS

Dennis Deaton: He addressed the council about the changes to the Community Park and not being asked back to work at the park. He read a letter from Doug DeJaco letting him know he would not be asked back to work and then read a letter from Mayor Rachford praising him for his work in 2017. He would like an explanation as to why he was not asked for an interview. Mayor Schabell gave an explanation about the direction for the seasonal staff at the park and the direction of the Public Works department to take over more of the maintenance work at the park. He expressed his apologies for not handling the situation better.

Julie, Independence: Addressed council about how Alexandria is the talk of other areas, and the city can do better.

ORDINANCES, RESOLUTIONS & MUNICIPAL ORDERS

Mr. Duncan read the following: Second Reading:

ORD 2023-04: An Ordinance of the City of Alexandria, in Campbell County, Kentucky, amending section 37.02 of the City of Alexandria Code of Ordinances, Ordinance 2022-02, and the City's Personnel and Pay Classification Plan, by amending the salary ranges for city employees in the document entitled City of Alexandria, Job Descriptions, Classifications and Salary Ranges for City Employees.

MOTION: Kyle Sparks made a motion to adopt Ordinance 2023-04. Susan Vanlandingham shared some feedback from citizens that was positive and in support of the Ordinance. Susan Vanlandingham seconded the motion. All in favor, the motion passed 6-0-0.

DEPARTMENT REPORTS



City Clerk: Ms. Tarter reminded the council to bring in their Code of Ordinance books so they can be updated with the latest supplement. She also reported she will be out of town attending the Clerks Spring Conference in Owensboro, KY.

City Administrator: Mr. Plummer reported he attended the OKI & KYTC meeting where they presented a list of projects and their rankings. The list then goes to the Legislature and Governor for approval. He reported there are 3 projects in the Alexandria area: truck climbing hill by Walmart, 709/US27/AA turn lanes and a 536 expansion. Council members were encouraged to push those projects when having conversations with those in Frankfort. He also reported there will be a new business opening in May in the Jolly Center near AutoZone where residents can ship packages; he will be working with them to get a ribbon cutting ceremony planned.

Police Department: See attached report. Chief Cooper reported they will have a couple of new hires starting over the next several weeks. The new vehicles have been outfitted and are on the road. The Drug take back will happen this weekend, no liquids. He also reminded residents golf carts are not allowed on the streets nor are 4-wheelers. The Police Department will donate helmets for the bikes for the raffle at the open house.

Public Works: See attached report. Mr. Dejaco reported a 5th employee was hired and he will start on Monday.
