APPROVAL OF MINUTES: September 7, 2023, Regular Meeting

The motion passed 5-0-0.

SCHEDULED VISITORS AND GUESTS

Jenni McBride & Senator Shelley Funke Frommeyer: Senator Shelley Funke Frommeyer shared one of the candidates running for Kentucky Governor will be at the Wilder city building on Monday, October 2 at 5:30pm. She then presented a Senate Citation and shared that Jenni McBride's action have a ripple effect on the other counties that she serves. Shelley shared some of the things Mrs. McBride has done throughout the years and throughout the community in Campbell County and the surrounding area. Mrs. McBride shared that she helps others even when she does not always have what is needed and the community shows up.

Sq. Nathan Noqueras: Chief Cooper read a letter of accommodation for Sg. Nathan Nogueras for his valorous act in performing CPR resulting in saving the patient's life. Sg. Nogueras was presented with the "Excellence in Service" award. The woman and her family attended the meeting as well. Sg. Nogueras expressed his gratitude for the team effort put forth to save Erin's life.

UNSCHEDULED VISITORS AND GUESTS

Dave Moehring and Dave Bohnen, Blue Roo Car Wash: The folks from the Arcadia Patio Homes are thankful for the hard work the city put in to develop a solution for the noise issue affecting the residents. The solution has been beneficial, and they are thankful the city saw the project to completion. Dave Moehring spoke with the neighbors on the other streets, and they also appreciate the effort of the city and notice a decrease in the sound. Mr. Moehring would like to see comparison readings of the decibels from before the sound wall to after the wall and wonders if another layer would help the problem even more.

Ordinance 2023-09: An Ordinance of the City of Alexandria, in Campbell County, Kentucky, amending sections of the City of Alexandria Code of Ordinances in order to adopt revisions pertaining to the enforcement of violations of city ordinances.

Mr. Duncan explained the Ordinance cleans up some minor typos and inconsistencies among different Ordinances regarding nuisance and enforcement in the Code of Ordinances.

DEPARTMENT REPORTS

City Clerk: Ms. Tarter reported the tax bills have gone out and residents should have received those. She encouraged residents to contact the office if they have not yet received their tax bill. There was also an update on the online payment portal; they ran into a slight issue and is being fixed.

City Administrator: He reported the fence and sound barrier have been installed at Blue Roo, he does have concern with adding any additional weight to the fence. The contractors are working on the new park shelter near the playground.

Police Department: See attached report. They have 3 new vehicles for the year and are being outfitted. He reported the data collector has been moved to a new area at the request of council. Their annual "Coffee with a Cop" event is October 10, 8:30-10:00.

Public Works: See attached report. He offered a correction; the contractors have not yet started on the park shelter but hope to get started on Friday.

Zoning/Code Enforcement: See attached report. Councilman Baldridge likes the report and the follow up that happens. Councilman Graus explained things are not changing with the way things are done, but now they have more information regarding what is taking place.

Stacey Graus: He expressed frustration regarding Rumpke coming into his subdivision at 5:30am and the city does take that seriously and will be addressing it with Rumpke. He also spoke about the inconsistency of the delivery of the Enquirer paper. Councilman Sparks has also seen some issues with the Rumpke service where there is trash left on the streets due to faulty equipment. Overall Rumpke does a good job and the number of times they are entering subdivisions too early has decreased over the years. It was suggested to have the Rumpke rep at a council meeting and maybe speak with the GM of Rumpke.
