APPROVAL OF MINUTES: September 21, 2023, Regular Meeting

MOTION: Tom Baldridge made a motion to approve the minutes of the September 21, 2023, Regular Meeting, seconded by Robert Strong. All in favor, the motion passed 5-0-0.

UNSCHEDULED VISITORS AND GUESTS

Jack Walters, Serendipity for the Home: Mr. Walters thanked council for the event at Main Street Bored Games Café and found it helpful to communicate with the small businesses in the downtown area. Some of the things discussed at the meeting was more lighting in the downtown area, more spots to stop and rest, painting the lines on the street for parking and more trash cans. He also shared that there are some old buildings that have lights but they are not working, it is a safety hazard. There was some discussion regarding who would be responsible for the lighting along the state-maintained road of East Main. Mayor Schabell said the city can investigate the lights and into adding more lighting into the downtown area. Councilman Baldridge encouraged him to attend the next Business Retention & Development committee. Councilman Graus encouraged him to reach out to the Eagle Scouts to build benches and it was also suggested to work with the Park and Recreation Board for memorial benches.

ORDINANCES, RESOLUTIONS & MUNICIPAL ORDERS

Mike Duncan read the following, 2nd reading:

Ordinance 2023-09: An Ordinance of the City of Alexandria, in Campbell County, Kentucky, amending sections of the City of Alexandria Code of Ordinances in order to adopt revisions pertaining to the enforcement of violations of city ordinances.

Mr. Duncan noted there were a couple of slight revisions from the first reading of the Ordinance.

MOTION: Susan Vanlandingham made a motion to approve Ordinance 2023-09 with amendments, seconded by Tom Baldridge. All in favor, the motion passed 5-0-0.

Mike Duncan then read the following, 1st reading:

Ordinance 2023-10: An Ordinance of the City of Alexandria, in Campbell County, Kentucky, amending Section 111.02 of the City of Alexandria Code of Ordinances in order to revise the provisions pertaining to Itinerant merchants.

Mike Duncan explained the reason for the changes is for folks who sell at farmer's markets to be able to sell their goods once per week as long as they have an occupational license with the city.

Ordinance 2023-11: An Ordinance of the City of Alexandria, in Campbell County, Kentucky, amending section 37.02 of the City of Alexandria Code of Ordinances and the City's Personnel and Pay Classification Plan by amending the salary ranges for City Public Works employees.

Exhibit A shows the amendments to the pay scales for PW. Mr. Plummer explained they also did this for the Police Department. It was asked if pay was compared to other cities in the area and it was pointed out the bar graph contains that information.

Executive Order 2023-06: An Executive Order of the Mayor of the City of Alexandria, Campbell County, Kentucky promulgating revisions to the Personnel Policy for the City of Alexandria pertaining to employee training in the Employee Handbook.

Council has until the next council meeting on October 19, 2023, to refuse the changes.

DEPARTMENT REPORTS

City Clerk: Ms. Tarter reported they are busy collecting property tax bills and to date have collected around \$400,000. She also pointed out residents can pay their property taxes online as well if they are not able to make it into the office or don't want to mail in a check.

City Administrator: See attached report. He reported the grant that was submitted to install a sidewalk from Thatcher down to Stillwater looks like it might be approved. He gave a brief review of the KLC Conference and encouraged council to attend in the future.
