# CITY COUNCIL MEETING Meeting Minutes of March 21, 2024

Mayor Schabell asked for a moment of silence in remembrance of Calvin A. Perry who passed away this week and for whom the Community Center is named after; followed by the pledge to the flag.

### APPROVAL OF MINUTES: March 7, 2024, Regular Meeting

**MOTION:** Tom Baldridge made a motion to approve the minutes of the March 7, 2024, Regular Meeting, seconded by Susan Vanlandingham. All in favor, the motion passed 4-0-0.

# SCHEDULED VISITORS AND GUESTS

Chief Tim Ford & Chief Jim Bell, Fire District Merger – They gave an overview of the merger between Alexandria Fire District and Southern Campbell Fire District and will be presented for approval at the Campbell County Fiscal Court meeting on April 3. Effective July 1 they will be one fire district. Not much will change between the departments and the residents will not see much difference in service. They have already started to blend their crews together. Andy Schabell asked about taxes and if the city residents would see an increase in the rate and he believes this will be good for everyone. Tim Ford shared that they received their new ladder truck and will be put into service sometime in April. They gave a quick overview of some of the other equipment they have received and will be in service soon.

Mike Ward & Bill Rachford, KY Veterans Hall of Fame Monument – Mike Ward shared some information regarding when the Tribute Park was built and asked that the city consider moving the Tribute Park to the new city campus. Tribute Park was put in without money from the city but all through donations. He believes that at the new city campus folks would have more opportunity to sit and enjoy the monument. Bill Rachford shared about Kentucky Hall of Fame and some of the details regarding how it started and current inductees. He also shared details about who can be inducted into the Hall of Fame. Thirteen members are from Campbell County and seven of them live in Alexandria, he then shared the inductees' names and the year they were inducted. Mr. Rachford suggested adding a tribute to the Hall of Fame memorial to the Tribute Park when it is moved to the new city campus. He shared a picture of a monument from Kenton County, and he believes that Alexandria is the best location for a monument considering Alexandria is the original County seed. Kyle Sparks asked for examples of other cities that have incorporated these types of monuments at their city building/campus; Highland Heights and Fort Thomas both have memorials at their city campus'. Mayor Schabell shared that the city is still on the interior design, and this is a good time to present the idea and included in the campus design.

**Ordinance 2024-02** (1st Reading): An Ordinance of the City of Alexandria, in Campbell County, Kentucky, amending section 37.02 of the City of Alexandria Code of Ordinances and the city's Personnel and Pay Classification plan by 1) creating the position of Assistant Director of Recreation, 2) adopting the job description for the Assistant Director of Recreation, and 3) amending the salary ranges for city employees to include the Assistant Director of Recreation.

Proclamation 2024-02: Julius "Dude" Hogle Day, March 27, 2024

Proclamation 2024-03: Dale Reid Day, March 29, 2024

**Resolution 2024-02:** A Resolution of the City of Alexandria, in Campbell County, Kentucky, authorizing and directing the Mayor to execute a contract with Pepper Construction Company of Ohio, LLC to provide preconstruction and construction management services for the city's new city building and community center campus project.

Jerry Noble – Pepper Construction, he gave an overview of their company and years of service and places they have worked. Tim Burner, Senior Project Manager. Mr. Plummer gave an overview of the Construction Manager at Risk and the process to get to where the city is as of today. There was an interview process and safety ratings put Pepper Construction.
