### APPROVAL OF MINUTES: November 21, 2024, Regular Meeting

**MOTION:** Kyle Sparks made a motion to approve the minutes of the November 21, 2024, Regular Meeting, seconded by Tom Baldridge. All in favor, the motion passed 6-0-0.

#### **SCHEDULED VISITORS AND GUESTS**

**Audit Presentation, John Chamberlin:** Mr. Chamberlin introduced himself and thanked the city for the hard work and cooperation of the staff during the audit. He reviewed the slides (see attached). There were no significant deficiencies or non-compliance. A governance letter will be supplied to council and a management letter was provided to management. He shared a comparison of the past three years for asset comparison and all governmental funds comparison. The city currently has a 24-month reserve of operation budget cash on hand. He also shared a three-year comparison of the city-wide debt of all fund types. There was a brief overview of the Kentucky retirement liability for the city and how it has decreased over the past year and is likely to decrease for this year as well. He reviewed the comparison between the revenue vs. expenses.

Mr. Graus stated the city is in a good position financially and that it continues to increase each year. He remembers a time when the city was lucky to break even. Stated it has helped that the market is good right now. Gave credit to the Mayor, Council and the city employees.

#### ORDINANCES, RESOLUTIONS & MUNICIPAL ORDERS

**Resolution 2024-13:** A Resolution of the City of Alexandria, in Campbell County, Kentucky, authorizing and directing the Mayor or his designee to execute an addendum to the Rumpke Contract for residential waste & curbside recycling collection services, in order to renew the contract for the second option year.

Mr. Plummer briefly discussed the history with Rumpke regarding their service and contract.

**MOTION:** Stacey Graus made a motion to accept Resolution 2024-13, seconded by Patrick Blair. Stacey Graus believes Rumpke does a good job, but his only complaint is they come into the communities too early. All in favor, the motion passed 6-0-0.

**Resolution 2024-14:** A resolution of the City of Alexandria, in Campbell County, Kentucky, authorizing and directing the Mayor to execute a contract with Atlas Technical Consultants, LLC to provide special inspection services for the city's new city campus project.

**MOTION:** Robert Strong made a motion to approve Resolution 2024-14, seconded by Tom Baldrige. Mayor Schabell added the city has worked with them for the Geothermal and Pepper Construction recommended them as easy to work with. All in favor, the motion passed 6-0-0.

**City Clerk:** Ms. Tarter made mention of the Facebook post about the Christmas/Winter Beautification Award. Also advised, delinquent tax notices will be sent out this week. The city will also repost about the rebranding of the logo.

Mr. Plummer advised that there has been an applicant that won the lottery for a cannabis store to be here in Alexandria, he mentioned that he will be creating an Ordinance for a licensing structure, Planning & Zoning does have a public hearing regarding this matter on December 17. He reviewed the Code Enforcement Payment & Policy and applying liens for unpaid citations. He also mentioned the company name for Service line Warranties to will change to Utility Service Partner Private Label, this will not affect how they do business or the contract with the city. They have agreed to not use the city logo moving forward.
