Municipal Order 2024-30: A Municipal Order of the City of Alexandria appointing and approving Tony Webb to a full four-year term on the City of Alexandria Board Planning & Zoning Commission.

MOTION: Robert Strong made a motion to approve Municipal Order 2024-29 & 2024-30, seconded by Patrick Blair. Andy Schabell explained the process of appointing Dave and Tony to Planning & Zoning. All in favor, the motion passed 5-0-0.

Ordinance 2024-11 (1st Reading): An Ordinance of the City of Alexandria, in Campbell County, Kentucky, adopting amendments to Title XI of the City's Code of Ordinances in order to regulate the operation of medical cannabis businesses in the city.

This ordinance pertains to the regulation and fees of the business operation. Mr. Duncan went on to explain the Planning & Zoning have been working on text amendments. A location within the city was chosen inside of Alexandria. Mayor Schabell explained that all the cities within the state that put the question to the voters passed. Mr. Duncan explained what the zoning text amendment includes regarding distance and zones.

David Plummer added some clarification to a news article that claimed the old PNC Bank was the selected location but that is not accurate it is the old Truist Bank. He also explained the process for the business to get up and running.
