APPROVAL OF MINUTES: February 20, 2025, Regular Meeting

MOTION: Tom Baldridge made a motion to approve the minutes of February 20, 2025, Regular Meeting, seconded by Robert Strong. All in favor, the motion passed 6-0-0.

UNSCHEDULED VISITORS AND GUESTS

Jack Walters, Serendipity for the Home: They have had 10 vendors sign up for the May 3 Business Showcase so far. Mr. Walter's handed out a flyer for their June 7 event in conjunction with Children's Entrepreneur market based out of Cincinnati. They promote and teach children how to run a business and they will be selling their goods at the June 7 festival. He is currently working through what to charge the children for their booth and asked for suggestions.

ORDINANCES, RESOLUTIONS & MUNICIPAL ORDERS

(Mike Duncan read the following.)

Ordinance 2025-02 (1st Reading): An Ordinance of the City of Alexandria, in Campbell County, Kentucky, approving a lease agreement for the financing of a project; providing for the payment of and security for the lease; affirming the maintenance of the existing sinking fund; and authorizing the execution of various documents related to the lease.

Mr. Duncan explained this is one part that is needed for the financing of the new city campus.

Ordinance 2025-03 (1st Reading): An Ordinance of the City of Alexandria, in Campbell County, Kentucky, approving a recommendation of the Alexandria Planning Commission, in order to adopt text amendments to the Alexandria Zoning Ordinance in order to provide regulations for alcoholic beverages, tobacco and electronic smoking device (VAPE) businesses in the city.

Mr. Duncan explained the city adopted a moratorium on these types of businesses until the planning commission had a chance to review the current zoning regulations and make recommendations to council. He shared specific excerpts from the exhibits for the Ordinance.

Ordinance 2025-04 (1st Reading): An Ordinance of the City of Alexandria, in Campbell County, Kentucky, approving a recommendation of the Alexandria Planning Commission to approve a zoning map amendment for the Grandview Development LLC real estate located at 2428

Grandview Road, from Highway Commercial (HC) zone to Residential Rural Estate (R-RE) zone, in order to apply the zoning classification that matches the use of the real estate.

Mr. Duncan gave the history of the previous rezoning of the lot and the house is separate from the parcel that will remain zoned HC.

Resolution 2025-03: A Resolution of the City of Alexandria, in Campbell County, Kentucky, approving an interlocal cooperation agreement by and among the city and various public agencies regarding the Kentucky Bond Corporation.

This will allow the city to enter into an interlocal agreement in order to pursue bond financing for the new city campus.

MOTION: Tom Baldridge made a motion to approve Resolution 2025-03, seconded by Robert Strong. All in favor, the motion passed 6-0-0.

Resolution 2025-04: A Resolution of the City of Alexandria, in Campbell County, Kentucky, authorizing and directing the Mayor to execute a contract with CT Consultants, a Verdantas Company, to provide engineering services for the city's Transportation Alternatives (TA) Grant for the East Main Street sidewalk project phase 1.

MOTION: Stacey Graus made a motion to approve Resolution 2025-04, seconded by Patrick Blair. All in favor, the motion passed 6-0-0.
