E. Main Street Sidewalk

Dear Neighbor,

The City of Alexandria would like to invite you to a public meeting. Public input is an important part of the project development process and provides valuable feedback that helps guide decision-making through all phases of development. The City is proposing a project to construct a new sidewalk along the north/east side of E. Main Street (KY 10) from 8431 E. Main Street (near the intersection with Thatcher Avenue) to connect to the existing sidewalk along Stillwater Drive in Alexandria, KY. A map with the proposed project limits is shown below.



The purpose of this project is to improve pedestrian safety and connectivity along E. Main Street. The proposed projects will not change the current traffic configuration of two lanes in each direction. The sidewalk installation is anticipated to include replacement of driveway aprons as well as the installation of new or replacement curb. Sections of relatively short retaining wall may also be included. The project is tentatively scheduled to be constructed during the 2027 construction season. Additional notices will be provided prior to construction.

Civil engineering consultants to the City of Alexandria, Verdantas, will present conceptual design information for the E. Main Street Sidewalk project on June 25, 2025, at 6:00 P.M at the Alexandria City Hall located at 8236 West Main Street., Alexandria, KY 41001.
