David Plummer updated the board, Alexandria residents voted in favor of medical cannabis and a dispensary set to locate in Alexandria won the lottery. The Planning & Zoning did make a recommendation to Council to allow dispensaries in our Highway Commercial Zone, as a conditional use. Any license that would come through in the future would go in front of the Board of Adjustment. What they sell here in Kentucky must be grown here in Kentucky, so there will be a five-to-six-month lag.

There was a question regarding what they will be allowed to regulate. Mr. Plummer explained there are State Regulations, the city did add some additional regulations. Ms. Minter with the Campbell County Planning & Zoning would have a case prepared for them with any future applicants.

Dirk Glahn spoke briefly about the research he did on the company, he believes they are an established company. Thanked the city for the hard work they have put into it and staying ahead of the game on this matter.

Mr. Plummer gave a brief update on the new site, stating the groundbreaking ceremony was a great turnout. Construction on the new building should start sometime in April, you should start seeing things happen within this next month on site.
