

CITY COUNCIL MEETING Meeting Minutes of August 21, 2025

Mayor Andy Schabell called the Alexandria City Council Meeting to order at 7:00 p.m. followed by the invocation and the pledge to the flag. The following Council Members answering roll call:

Mayor Schabell opened the public hearing at 7:00pm.

PUBLIC HEARING:

The City of Alexandria proposes a tax rate which will exceed the compensating tax rate, but the proposed rate is the same as the preceding year. Additionally, the proposed rate is expected to produce revenue from real property, exclusive of revenue from new property, of less than four percent (4%) over the amount of revenue which would be produced by the compensating tax rate. The revenue in excess of the revenue produced in the preceding year is proposed to be allocated to the General Fund to be administered according to the budget for fiscal year 2025-2026. The purpose of this public hearing is to receive taxpayer input on the proposed tax rate for 2025. This notice is required by KRS 132.027 as passed by the Kentucky General Assembly.

Alicia Mueller: Questioned what the additional funds will be used for. Mr. Graus explained the money will go into the general fund, used for any service that the city may need. There will be no specific line where the money will go. He added, the city is growing, and with that comes additional services that are required. Mr. Baldridge added that he would like to see some of that money go toward public works.

Mayor Schabell closed the public hearing at 7:08pm.

APPROVAL OF MINUTES: August 7, 2025, Regular Meeting

MOTION: Tom Baldridge made a motion to approve the minutes of August 7, 2025, Regular Meeting, seconded by Patrick Blair. All in favor, the motion passed 6-0-0.

ORDINANCES, RESOLUTIONS & MUNICIPAL ORDERS

(Mike Duncan read the following.)

Ordinance 2025-11 (2nd *Reading*): An Ordinance of the City of Alexandria, in Campbell County, Kentucky, approving a recommendation of the Alexandria Planning Commission, in order to adopt text amendments to the Alexandria Zoning Ordinance in order to revise regulations for alcoholic beverages, tobacco, electronic smoking device (vape) businesses, and rear yard setback regulations in the city.

MOTION: Bob Strong made a motion to approve Ordinance 2025-11, seconded by Tom Baldridge. All in favor, the motion passed 6-0-0.

Ordinance 2025-12 (2nd Reading): An Ordinance of the City of Alexandria, in Campbell County, Kentucky, amending section 37.02 of the City of Alexandria Code of Ordinances and the City's Personnel and Pay Classification Plan by amending the salary range for Police Sergeants.

MOTION: Michael McGrath made a motion to approve Ordinance 2025-12, seconded by Patrick Blair. All in favor, the motion passed 6-0-0.

Mr. Baldridge had a question about whether we are matching with other departments. Chief Cooper advised other departments are starting a Sergeant at 80,000, as we are topping them out at 80,000.

Ordinance 2025-13 (1st Reading): An Ordinance of the City of Alexandria, in Campbell County, Kentucky, providing for the assessment of real property within the corporate limits of the City of Alexandria and levying an Ad Valorem Tax of \$0.140 on each one hundred dollars (\$100.00) of assessed valuation (1.40 per thousand) of real property in the city for the 2025 assessment tax year and specifying the purpose for which the tax is levied.

Ordinance 2025-14 (1st Reading): An Ordinance of the City of Alexandria, In Campbell County, Kentucky, Amending Chapter 90 of the City of Alexandria Code of Ordinance by adding section 90.10 therein in order to adopt the Campbell County Animal Services fines and fees schedule Pursuant to interlocal agreement.

Municipal Order 2025-17: A Municipal Order of the City of Alexandria appointing and approving Thomas Simpson to fill the unexpired term of Michele Nelson on the city of Alexandria Planning & Zoning commission for the remainder of her four-year term to expire on December 31, 2027, or as soon as his successor is appointed, approved, is qualified and sworn in.

Mrs. Fincher had a question as to why he was interested in the position. Mr. Simpson stated he is semi-retired and loves this community and thought why not help out.

Motion: Robert Strong made a motion to accept Municipal Order 2025-17, seconded by Michael McGrath. All in favor, the motion passed, 6-0-0.

Municipal Order 2025-18: A Municipal Order of the City of Alexandria appointing and approving Rachel Sheley to fill the unexpired term of Dave Downing on the City of Alexandria Board of Ethics for the remainder of his three-year term to expire on December 31, 2026, or as soon as her successor is appointed, approved, is gualified and sworn in.

Motion: Robert Strong made a motion to accept Municipal Order 2025-18, seconded by Patrick Blair. All in favor, the motion passed, 6-0-0.

DEPARTMENT REPORTS

City Clerk: Mrs. Snyder reminded Council if they would like to walk in the parade to be at the Middle School by 6pm due to roads shutting down at the time.

City Administrator: Mr. Plummer gave an update about Wawa, they are expecting to go into construction next month. They are currently looking for spots for the underground storage tanks, they will have to drain all of the groundwater out of the site, they are currently waiting for approvals from SD1 to do this. He also gave a brief update about the pickleball courts, he advised they were milled out last week and looking at mid-September for paint crew. There was a question about the ETA on turn lane going into Walmart. Mr. Plummer mentioned he heard that perhaps the project is going to start maybe later in the fall.
