



ORDINANCE 2025-14

AN ORDINANCE OF THE CITY OF ALEXANDRIA, IN CAMPBELL COUNTY, KENTUCKY, AMENDING CHAPTER 90 OF THE CITY OF ALEXANDRIA CODE OF ORDINANCES BY ADDING SECTION 90.10 THEREIN IN ORDER TO ADOPT THE CAMPBELL COUNTY ANIMAL SERVICES FINES AND FEES SCHEDULE PURSUANT TO INTERLOCAL AGREEMENT.

WHEREAS, the City of Alexandria is in need of animal control services; and

WHEREAS, pursuant to KRS 258.195, the County's Animal Control Officers and Animal Services employees have jurisdiction within the City limits to enforce any City ordinance related to animal control; and

WHEREAS, the Campbell County Fiscal Court has agreed to provide full animal control services for the Campbell County cities, and has submitted an Interlocal Agreement to carry out the parties' agreements; and

WHEREAS, the City of Alexandria has adopted Resolution 2025-11 approving the Interlocal Agreement, Section Four of which requires the City to adopt and maintain uniform animal citation penalties for violations of the City animal control Ordinances.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF ALEXANDRIA, CAMPBELL COUNTY, KENTUCKY, AS FOLLOWS:

SECTION 1. Chapter 90 of the City of Alexandria Code of Ordinances is hereby amended by adopting and adding Section 90.10 therein as follows:

§ 90.10 CAMPBELL COUNTY UNIFORM ANIMAL CITATION PENALTIES.

(A) It shall be unlawful for any owner or keeper of any animal in the City of Alexandria to engage in or to allow the following violations:

(1) Failure to vaccinate a pet against rabies;

(2) Failure to license a pet;

(3) Create a public nuisance;

(4) Curbing and/or failure to clean up animal excrement in public place or other private property;

(5) Animal running at large; or

(6) Lack of reasonable grooming or veterinary care where the animal has not suffered harm.

- (B) The penalties for all above-mentioned violations are as follows:
- (1) First Offense: \$30 Fine;
- (2) Second Offense, within 12 months: \$55 Fine;
- (3) Third Offense, within 12 months: \$85 Fine; and
- (4) Fourth Offense, within 12 months: Owner will be cited to Court.
- (C) Fines for the First, Second or Third Offense must be paid within 14 days of notice of the violation and fine due. If fines are not paid within 14 days, Owner may be cited to court.
- (D) All such fines and/or fees will be kept by Campbel County to offset impound expenses.

SECTION 2. This Ordinance shall be effective upon its adoption, approval, and publication according to laws; this Ordinance may be published by Summary.

SECTION 3. All Ordinances or parts of any Ordinances in conflict therewith, to the extent of such conflict, if any, are hereby repealed.

SECTION 4. The foregoing ordinance was introduced by Council Member Patrick Blair, was read, passed and adopted by Council of the City of Alexandria, Kentucky, meeting in **regular sessions on the 21st day of August, 2025, and on the 4th day of September, 2025, with 6 Yes votes, 0 No votes, and 0 Abstentions**, and was thereafter approved by the Mayor and ordered published in Summary according to law.
