CITY ORD 92.03 Certain Conditions Declared a Nuisance: It shall be unlawful for the owner, occupant, or person having control or management of any land within the city to permit a public nuisance, health hazard, or source of filth (collectively referred to as “public nuisance”) to develop thereon. The following conditions are declared to be public nuisances: (K) The parking of any motor vehicle, motorcycle or any other similar type equipment on or across any sidewalk which hinders the free movement thereof. (Vehicle not permitted to park across the sidewalk apron, previous letter issued one month ago for same issue)

NOTICE

The violation with which you have been charged is a civil offense pursuant to Alexandria Code of Ordinances.

To appeal this citation, the person to whom the citation is issued shall file in writing or via email a request with the City Clerk at the City of Alexandria City Building, 8236 West Main Street Alexandria, KY 41001 within ten (10) days **(10/09/2025)** of the citation being issued. Failure to request a hearing, in writing or via email within ten (10) days shall constitute a waiver of your right to contest the citation and the determination that a violation was committed shall be final and non-appealable.

If you choose to appeal the citation and request a hearing before the Code Enforcement Board, the Board may set a fine at its discretion between \$20.00 and \$200.00 for a first offense, between \$60.00 and \$600.00 for a second offense, and between \$180.00 and \$1,800.00 for a third offense.
