City Ord 92.03 CERTAIN CONDITIONS DECLARED A NUISANCE: It shall be unlawful for the owner, occupant, or person having control or management of any land within the city to permit a public nuisance, health hazard, or source of filth (collectively referred to as “public nuisance”) to develop thereon. The following conditions are declared to be public nuisances:

(K) The parking of any motor vehicle, motorcycle or any other similar type equipment on or across any sidewalk which hinders the free movement thereof. (**Vehicle not permitted to park across the sidewalk apron**)

NOTICE

The violation with which you have been charged is a civil offense pursuant to Alexandria Code of Ordinances.

To appeal this citation, the person to whom the citation is issued shall file in writing or via email a request with the City Clerk at the City of Alexandria City Building, 8236 West Main Street Alexandria, KY 41001 within ten (10) days (**10/06/2025**) of the citation being issued. Failure to pay the applicable civil penalty or request a hearing, in writing or via email within ten (10) days shall constitute a waiver of your right to contest the citation and the determination that a violation was committed shall be final and non-appealable.

If you choose to appeal the citation and request a hearing before the Code Enforcement Board, the Board may set a fine at its discretion between \$20.00 and \$200.00 for a first offense, between \$60.00 and \$600.00 for a second offense, and between \$180.00 and \$1,800.00 for a third offense.
