**VIOLATIONS:** (TWO) \$750.00 Total

**IPMC 302.1 Sanitation.** All exterior property and premises shall be maintained in a clean, safe, and sanitary condition. The occupant shall keep that part of the exterior property which such occupant occupies or controls in a clean and sanitary condition. (Exterior premises cannot be used for storage of any kind. Tires, wheels, vehicle parts, a bobcat, a motor, and other items still clutter the front lot. ALL of these items need to be stored inside or in a closed container in your back lot at ALL times. Your lot needs to be cleaned up and remain free of these items)

**IPMC 302.8 Motor vehicles.** Except as provided for in other regulations, inoperative or unlicensed motor vehicles shall not be parked, kept or stored on any premises, and vehicles shall not at any time be in a state of major disassembly, disrepair, or in the process of being stripped or dismantled. (Vehicle on your front lot must be licensed and cannot be in a state of disrepair at any time, vehicles must be worked on inside the shop. There are still vehicles with expired or no registration plates, these vehicles have been on the lot since the last inspection)

### NOTICE

The violation with which you have been charged is a civil offense pursuant to Alexandria Code of Ordinances.

To appeal this citation, the person to whom the citation is issued shall file in writing or via email a request with the City Clerk at the City of Alexandria City Building, 8236 West Main Street Alexandria, KY 41001 within ten (10) days (12/19/2025) of the citation being issued. Failure to request a hearing, in writing or via email within ten (10) days shall constitute a waiver of your right to contest the citation and the determination that a violation was committed shall be final and non-appealable.

If you choose to appeal the citation and request a hearing before the Code Enforcement Board, the Board may set a fine at its discretion between \$20.00 and \$200.00 for a first offense, between \$60.00 and \$600.00 for a second offense, and between \$180.00 and \$1,800.00 for a third offense.
