CITY ORD 92.03 Certain Conditions Declared a Nuisance: It shall be unlawful for the owner, occupant, or person having control or management of any land within the city to permit a public nuisance, health hazard, or source of filth (collectively referred to as “public nuisance”) to develop thereon. The following conditions are declared to be public nuisances: **(L)** The parking of any motor vehicle, motorcycle, dormant lawn equipment or any other type equipment on the grass, sidewalk or porch in the front yard. **(Vehicles are still parked in the grass after two letters, this is not permitted by City Ordinance)**

NOTICE

The violation with which you have been charged is a civil offense pursuant to Alexandria Code of Ordinances.

To appeal this citation, the person to whom the citation is issued shall file in writing or via email a request with the City Clerk at the City of Alexandria City Building, 8236 West Main Street Alexandria, KY 41001 within ten (10) days **(12/05/2025)** of the citation being issued. Failure to request a hearing, in writing or via email within ten (10) days shall constitute a waiver of your right to contest the citation and the determination that a violation was committed shall be final and non-appealable.

If you choose to appeal the citation and request a hearing before the Code Enforcement Board, the Board may set a fine at its discretion between \$20.00 and \$200.00 for a first offense, between \$60.00 and \$600.00 for a second offense, and between \$180.00 and \$1,800.00 for a third offense.
