**VIOLATION(s): ONE \$300.00**

**CITY ORD 90.30 (D) KEEPING OR RAISING RABBITS OR CHICKENS.** It shall be unlawful for any one(1) family to keep or raise more than ten (10) rabbits and ten (10) chickens if their lot or parcel is less than two (2) acres. It shall be unlawful to let any rabbits or chickens run at large; and it shall be unlawful to keep or raise rabbits or chickens or to maintain any coop, hutch, building, or enclosure for them in an unclean or unsanitary condition. (Your chickens are still on-site with no one living at the property. I observed the coop; there was no food and no water visible in the coop. I observed feces throughout the coop. If the chickens are not moved within the next 10 days another citation will be issued for lack of maintenance of the chickens)

THE UNDERSIGNED CODE ENFORCEMENT OFFICER OF THE CITY OF ALEXANDRIA CERTIFIES THAT HE/SHE HAS JUST AND REASONABLE GROUNDS TO BELIEVE, AND DOES BELIEVE, THAT ON: **04/24/2026, I observed chickens in coop with no water and no food, feces scattered all over coop. Owner had over a month to remove the chickens; neighbors confirmed no one is living at the property.**

Failure to request a hearing, in writing or via email within ten (10) days shall constitute a waiver of your right to contest the citation and the determination that a violation was committed shall be final and non-appealable.

If you choose to appeal the citation and request a hearing before the Code Enforcement Board, the Board may set a fine at its discretion between \$20.00 and \$200.00 for a first offense, between \$60.00 and \$600.00 for a second offense, and between \$180.00 and \$1,800.00 for a third offense.
